Dear Mr Brown

Freedom of Information Determination

I refer to your application made under the *Freedom of Information Act 1991* (the Act) seeking access to:

"All documents (including but not limited to reports, briefings, emails, notes, minutes, plans and other documents) held by the Department mentioning or related to the Mawson Lakes Park Way Child Care Centre or the property at 5 Park Way, Mawson Lakes from 1 January 2019 to 17 January 2020."

A comprehensive search of Renewal SA has been undertaken which has identified 151 documents which meet the scope of your application and are listed in the attached document schedule.

I have determined that access is granted to 130 documents in full; 14 documents will be released in part and access to 7 documents are refused.

A schedule of documents is attached and a detailed explanation of the specific clause relied upon is set out below.

I have determined to refuse access to documents 2a, 5a, 9a, 48b, 52b, 56b and 57d in part as they are exempt pursuant to clause 6 of Schedule 1 of the FOI Act which provides:

6—Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

These documents contain the name of a constituent which would be unreasonable to disclose.

I have determined to refuse access to documents 8, 27, 28, 29 and 34 in part and 4c, 8a, 19a, 25a and 30a in full as they are exempt pursuant to clauses 7 and 16 of Schedule 1 of the FOI Act which provides:



7—Documents affecting business affairs

- (1) A document is an exempt document—
 - (b) if it contains matter—
 - (i) consisting of information (other than trade secrets) that has a commercial value to any agency or any other person; and
 - (ii) the disclosure of which—
 - (A) could reasonably be expected to destroy or diminish the commercial value of the information; and
 - (B) would, on balance, be contrary to the public interest; or
 - (c) if it contains matter-
 - (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
 - (ii) the disclosure of which-
 - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
 - (B) would, on balance, be contrary to the public interest.

16—Documents concerning operations of agencies

- (1) A document is an exempt document if it contains matter the disclosure of which—
 - (a) could reasonably be expected—
 - (iv) to have a substantial adverse effect on the effective performance by an agency of the agency's functions; or
 - (b) would, on balance, be contrary to the public interest.
 - (2) A document is an exempt document if—
 - (a) it relates to an agency engaged in commercial activities; and
 - (b) it contains matter the disclosure of which could prejudice the competitiveness of the agency in carrying on those commercial activities.

In accordance with Premier and Cabinet Circular 114 (PCO114), the Urban Renewal Authority (trading as Renewal SA) is responsible for the purchase and/or disposal of real property on behalf of government agencies, thus Renewal SA is considered to be an agency engaged in commercial activities.

The documents contain specialised advice between Renewal SA staff regarding future options and strategies, including on the potential sale of land located at 5 Park Way, Mawson Lakes.

Whilst it has been determined to sell the land, a sales agent has not yet been engaged and it is not yet on the market. Disclosure of any strategies pertaining to the sale of the land and its current value which could severely impact Renewal SA's capacity to achieve the highest price for the land. It is in the public interest for this information to be kept confidential so that the Government has the opportunity to undertake negotiations with potential buyers to purchase the site at a price representing the highest value which, in turn benefits taxpayers and the public purse.

I have determined to refuse access to document 20a and 22a in part and 20b and 22b in full as the document is currently available for purchase pursuant to section 20(1)(c) of the FOI Act which provides:

20-Refusal of access

- (1) An agency may refuse access to a document—
 - (c) if it is a document that is usually and currently available for purchase;
